#### **Septic System Do's and Don'ts**

What goes down your drain can have a major impact on how well your septic system works. A garbage disposal takes a lot of water to move scraps down the drain. Once in the tank, some of the solids break down by bacterial action, but most of the grindings will have to be pumped out. Using a disposal could require you to have your tank pumped more often. Composting is a better way to recycle kitchen scraps. Plant only grass over and near the septic system. Roots from nearby trees and shrubs can cause damage.

Don't drive or park vehicles on any part of your septic system.

Don't drive or park vehicles on any part of your septic system. Doing so can compact the soil and damage the pipes. Your system should be inspected to determine if pumping is

needed every 3 to 5 years, depending on the number of persons in the household and the size of the system.

Don't put toxic household waste down the drain. Avoid fats, solvents, oils, disinfectants, paints, chemicals, pesticides, pharmaceuticals, motor vehicle fluids and poisons.

Don't treat your system like a garbage can. Avoid dental floss,

coffee grounds, cigarette butts, paper towels and diapers.

# **Spring & Summer Storm Safety Tips**

Spring and Summer brings beautiful weather to Cohoctah Township but is also the season for dangerous storms. Before a storm hits:

- Have a portable radio, flashlights and fresh batteries handy.
- Know the location of your electrical circuit box and how to turn the power on and off.
- Never operate a generator in your home, garage, basement or any other enclosed area. A generator needs to be at least 3 feet from an enclosed area as well as away from doors and windows where exhaust fumes and carbon monoxide can enter the home.
- Never fuel a generator while it is running. Turn the generator off and let it cool before refueling.
- If the power is out in your neighborhood, watch out for fallen wires, broken utility poles or tree limbs on power lines. Stay clear of power lines and anything a power line is touching.

#### Yard Maintenance & Junk!

By Township policy, the Board does not take action on anonymous complaints on possible violations to the zoning ordinance, such as failure to maintain a yard, or for junk on a property. Please be neighborly and considerate and maintain your yard, keep old vehicles or construction material in barns or garages and out of sight and keep animals on your own property. If your neighbor approaches you about an issue, please try to resolve the matter. Neighbors' working out their issues keeps the Township from having to take action and is better for everybody.

#### **Dust Control**

The Township will be putting applications of brine on the Township controlled dirt roads at least two times this season: around Memorial Day and Fourth of July. This is funded through the Township's voter approved road millage.

### **Alchin's Recycling/Drop-off Center**

Alchin's Disposal has a recycling drop off center located at 9900 W. Grand River; Fowlerville MI. Hours are 11am to 4pm Monday thru Thursday for recycling. The price for recycling is \$3.00 per visit. They offer an annual membership of \$20.00 per household or a senior (55 or older) annual membership of \$15.00 per household. # 2015-2016 TRASH DISPOSAL

Cohoctah Township contracts with Alchin's Disposal service for trash pickup. If you would like to participate, please read the guidelines and fill out the form below.

Service for July 1, 2015 through June 30, 2016 will still cost \$156. There are no refunds!

Senior Discounts (55 or older) are available directly from Alchin's Disposal, call 517-223-7119. 8am to 5pm. Do not pay the Township! Alchin's will bill you if you already have this senior service.

General Guidelines:

- A. The amount of trash collected weekly from each household will be limited to the equivalent of 6 (30 gallon) trash bags. Please stay within these limits. Call in advance for extra-large pickups.
- B. Trash must be placed at roadside by 6:00 a.m. pickup day. (Friday is pickup day for most of the township). Pickup will be the next working day after holidays or bad snow storms.
- C. Trash must be placed in plastic trash bags or garbage cans. Each trash container shall not weigh more than one person could reasonably be expected to lift.

- D. Excess trash and appliances and large items such as chairs, hot water tanks, etc. will be extra. The charge will be determined by the size and bulk of material. Pickup of these items must be arranged in advance. Call Alchin's at 517-223-7119.
- E. The trash collector will **NOT** pick up dirt, fire ash, dead animals, animal waste, grass clippings, shrubbery, brush or tree trimmings, flammable materials or any other items prohibited by law to be collected.
- F. Residents may rent a curb cart directly from Alchin's Disposal 517-223-7119. Do not send curb cart money to the Township! The cart fee is \$36 in 2015.

To start or renew service, your check for \$156 payable to Cohoctah Township must be received by June 30, 2015.

# Spring trash day scheduled for May 7, 2016

The board scheduled a large-item trash day for the spring of 2016. The purpose is to allow only our residents to dispose of old appliances, furniture and other items too large for regular trash service. (NOTE: propane tanks, fuel tanks, broken concrete, rocks, batteries, barrels and cans of paint cannot be taken.) We urge the residents to use these trash days to clean up the roads and ditches in the township. The 2016 spring trash day will be held on Saturday, May 7, 2016. Hours are from 8:00 a.m. to Noon at the Cohoctah Township Park at Allen and Preston Roads. Enter off of Allen. Appliances with Freon will be accepted but we must charge \$15 for each in order to properly dispose of them. There is no charge to residents for other items; we will be recycling tires so keep them separated. In order to make the process go faster, please try to organize your loads so that metal items are separated from the other trash and put on the back of your load so that they can be taken off first. # Who is Driving the Road Repairs?

Many residents do not realize that local roads, including construction and maintenance are under the jurisdiction of the County. The Township receives no State transportation funds. The Board works with the County Road Commission to set priorities for maintenance but over the past few years the county has had less to spend. Last year we spent money on road paving because the roads needed the work for safety. This is funded through monies in the general budget and funds from the Voter Approved road millage. We have more paved roads that badly need work and the Township will be paying to have work done again.
