

Cohoctah Township Board Minutes  
Livingston County

October 11, 2018

The regular meeting of the Cohoctah Township Board was called to order at 8:00 p.m. with the pledge to the flag. Present: Fosdick, Bock, Fear, Thurner, Charette, Zoning Admin. Flanary, and 12 citizens.

Agenda - Motion by Thurner, support by Charette to approve the agenda as amended. Motion carried 5/0.

Minutes of previous meeting - Motion by Thurner, support by Bock to approve Minutes as presented. Motion carried 5/0.

Treasurer's report – Motion by Thurner, support by Charette to receive the Treasurer's report as presented. Motion carried 5/0.

Call to the Public- Representatives from Livingston County 4-H presented the Township with a plaque in appreciation for the maintenance and use of the park.

Fire Authority – Leave on agenda.

Road Commission – Leave on agenda.

Cemetery – Leave on agenda.

Parks and Rec – The Park will be closing at the end of October.

Large Item Day Review- 78 Residents took advantage of the Large Item Day. There were 171 tires, 1 full metal container and 3 full garbage trucks. The weather may have contributed to a lower turn out. It has been suggested to continue providing 2 clean up days a year.

Thurner Resignations- Motion by Bock, support by Charette to accept Karen Thurners resignation from the Planning Commission effective October 12, 2018. Motion carried 5/0. Motion by Fosdick, support by Charette to accept William Thurners resignation as Trustee effective October 12, 2018. Motion carried 4/0. Thurner abstained.

Planning Commission Appointment- Motion by Fosdick, support by Bock to appoint Faith Heil to the Planning Commission to fill the vacancy left by Karen Thurner term expiring August 2021. Motion carried 5/0.

Trustee Appointment- Motion by Fosdick, support by Bock to appoint Mark Torigian to the Trustee position for the remainder of William Thurners term expiring on November 20, 2020. Motion carried 4/0. Thurner abstained from participation in discussion and voting.

Budget Review- The 2<sup>nd</sup> Quarter Budget expenditures were reviewed. Motion by Bock, support by Thurner to move \$3,000 from Contingencies to Election Supplies. Motion carried 5/0.

Lloyd Trailer Permit- The violation process will be started. Mr. Lloyd will work on getting the trailer removed in a reasonable amount of time.

Tributes- Motion by Fosdick, support by Charette to accept the Resolution of Tribute for William Thurner. Motion carried 4/0.

Motion by Fosdick, support by Charette to accept the Resolution of Tribute for Karen Thurner, Motion carried 5/0.

ZBA – No meeting.

Planning Commission – PC activity report given by Charette.

Violations / Complaint - Complaint 2018-001 has been reviewed and ZA Flanary will continue to monitor the complaint for an additional month to ensure full resolution. 2018-002 was reviewed and found to be a civil matter. The complaint has been closed.
